On November 23, 2015, the Town Board approved the Township's \$545,000 tax levy. That was -0.2% (about \$1,000) less than 2014. We are holding the line on taxes and expenses, becoming more efficient and effective when and where we can.

Putting this in perspective, there are about 17,000 people in the Township, so the cost per person is about \$0.09 per day. This allows us to provide our full range of programs and services, maintain and improve the building, support local agencies assisting youth, seniors and veterans

through small grants or sponsoring events, educate people about Townships and be part of other groups trying to improve the quality of life in Rock Island and the Quad Cities.

For example, I am honored to serve on the following:

- Habitat for Humanity Quad Cities Neighborhood Revitalization Advisory Board
- Rock Island / Milan School District's Council for Continuous Improvement
- Opportunities Quad Cities (anti-poverty group)
- Undependent Rock Island

I continue to have a strong emphasis on informing people about Townships and the services they offer. To that end, Don Wooten, local Renaissance Man and host of WVIK's "Saturday Morning Live" invited me to talk about Townships in general, and specific Rock Island Township activities, on September 19th. As I expected, topics ranged from what Townships do and whether they are needed to citizen expectations, community engagement and political philosophies. It made for a quick hour (at least from my perspective).

Our marketing and education efforts include our new full color, double sided LED message board sign, Facebook page and group, website and news releases. It is too easy to dismiss the importance of something if you are unaware what services or functions they offer or support. We'll continue using all of these media.

This newsletter is another of this multi-pronged effort to inform. If, after you read this newsletter, you have questions about programs, services, activities or functions, or if you have a suggestion for us to do something differently or new, let me know.



If you were born in 1951 you will be 65 this year which qualifies you to receive the **senior property tax exemptions**. You don't have to wait until your exact birthday, just drop in anytime and we'll get you signed up for the Homestead Exemption and check to see if you qualify for the Senior Freeze.

If you had the Senior Freeze last year you will have to renew it for 2016. When you come to see us, remember to bring something with you that verifies your income for 2015. Your Federal Tax Return is perfect. A statement from Social Security is also acceptable. As always, if you can't get to us, we'll come to you. Call 786-2961 and we'll set up a time that's convenient for you.



The **Disabled Persons Exemption** and the **Disabled Veterans Exemptions** also have to be renewed and some changes in the law came into effect in 2016.

NEW THIS YEAR:

- Veterans with a VA service connected disability rating of 30% or 40% can receive an exemption that takes \$2,500 off of their primary dwelling's equalized assessed value.
- Veterans with a VA service connected disability rating of 50% or 60% can receive an exemption that takes \$5,000 off of their primary dwelling's equalized assessed value.
- Veterans with a VA service-connected disability rating of 70% or greater can receive an exemption that makes all of their primary dwelling's equalized assessed value exempt from property taxation.

To be eligible for the Veterans exemptions:

The property must be the principal residence of the disabled veteran as of January 1st.

- The equalized assessed value of the property must be less than \$250,000 and it cannot be used for commercial purposes.
- You must produce your current VA award certificate and your DD214 that lists your discharge as honorable.
- Veterans must apply thru the Rock Island County Assessment Office, 1504 3rd Avenue, Rock Island, IL 309-558-3660

Beginning in 2015 an un-remarried surviving spouse of a veteran can also continue to receive the exemption on his/her spouse's primary residence, provided the exemption had previously been granted to the veteran.

The Owner/Occupied and the Senior Homestead exemptions do not have to be renewed each year.

We are currently working on assessments for the 2016 tax year for taxes that will be payable in 2017. We will turn these assessments in to the County by the middle of June, 2016. If you think that we may have some information about your property that is incorrect, **NOW** is the time to tell us. In 2015 did you rip off a porch or tear down a garage, add a room or turn your duplex back into a single family home? All of these items may affect the market value of your home.

The Clerk's role in government can be traced back to biblical times; we were called Remembrancers and Tax Collectors (some are still in existence today). In mid 17th century England we were called town clerks; a term used today at all Illinois townships. Some municipalities call us Secretaries. Whatever the term used — we all do the majority of items listed in the quote and then some! We are encouraged to help meet the needs in our specific communities in whatever ways we are able. Clerks do what needs to be done. It's that simple. The hard part is keeping aware of the new government standards that affect our township. Missed filing dates or inaccurate newspaper filings can cost fines from the state

and additional posting expenses. It is so important to keep up with changes in the laws that apply to our form of government.

I truly enjoy working behind the scenes or behind the lens of a camera. I really wonder if many of you would know who I am without a camera in my face! I really enjoy visiting with our

Township residents helping them by notarizing documents and often hearing of their history in our community! While voter registration closes 2/16/16, with all completed forms returned to the County Clerk's office within 48 hours, grace period registration/voting is open 2/17 – 3/14 provided you bring two forms of identification and vote at that time.

The guests are singles, families, elderly; some are just lonely, and don't desire to eat alone. All are grateful. Meals are served promptly at 5:30 p.m. Monday though Friday.


Rock Island Township continues to recognize our World War II Veterans with a salute to Rev. Gabriel Barber.

Gabriel Barber was born in Clarksville, Missouri on October 25th, 1927. Clarksville was his home until, at age 16, his family moved to Rock Island in search of a new home and better wages. He attended Rock Island High School for awhile; but decided to go to work at Farmall. In 1945, while on strike at Farmall, Gabriel decided to enlist in the United States Army.

The Army trained Barber as a truck driver and deployed him to Germany; that training put him in the field of transportation. He transported everything from food stuffs and soldiers to ammunition that had been buried underground. In 1947 he finished his tour of duty and returned home as a Private First Class.

Back home in Rock Island he completed his GED and married Lee, his lovely wife of 66 years. Gabriel and Lee set out to build a life together. They are the proud parents of three children. They have lived in the same house in Rock Island Township for 45 years! He retired from Farmall having served the company for 40 years. Gabriel was called to church ministry throughout his life. He retired as pastor of Davenport Temple Baptist Church after 28 years with the congregation. He is currently back home at Temple Baptist serving the people as Interim Pastor. He continues to serve when needed!

Rev. Barber has led a full life! While working at Farmall, leading and supporting many churches, he also found

time to serve his community. Gabriel served as a Trustee on the Rock Island Township Board for 12 years. He also served on the Rock Island County Board for approximately 30 years, retiring in 2007. The County Board recognized his service by naming a park in his and Lee's honor. Recently, the park was turned into a parking lot and the sign now appears between the Rock Island City Hall and the Rock Island County Office Building.

When asked after all he has done "what one thing made the greatest impact on you?" He responded that, while serving as the chairman of the committee overseeing Oak Glen and Rock Island Health Care facilities, he noticed many of the new residents came in undernourished and weak. It amazed him how quickly their strength returned with the change in their environment; along with proper nutrition.

Life Lessons Learned — he passes his wisdom on to young people; it's necessary for every family to raise their own children. Train them how to live in the community and be a part of the community.

Gabriel Barber — son, Army Private First Class, husband, provider, father, pastor and community leader. **Wonderful man!** It was an honor to hear and now share his story with you.

**EMERGENCY ASSISTANCE PROGRAM **

The Town Board approved an Emergency Assistance Program in 2015. We will continue offering it this year. We can pay your rent, mortgage or utilities (water / sewer or gas / electricity) up to a maximum of \$400 if you were unable to do so because of an emergency situation. An emergency could be a job loss or reduction in work hours, medical expenses, auto or appliance repair or replacement. We do not pay for these directly, but cover rent, etc. if you used those funds to pay for the emergency.

If you qualify for our General Assistance program, you are not eligible for this program. Application forms are available during regular business hours. We helped 43 applicants between September – December 2015. We hope to assist another 50 families during 2016. **Call 788-3417 for more information.**

TOWNSHIP GRANTS \\\


We have limited funding to support agencies and organizations providing services and programs that benefit youth, seniors and veterans. Past grants were awarded to local food pantries, the King Center's A.C.T.I.V.E. Club, Rock Island Little League, Community Gardens, Rocktown 340 Basketball Club, among others. If you are interested in receiving a grant application, contact the Township at 788-3417 or go to our website where you can download it.

GENERAL ASSISTANCE PROGRAM \\\\

If you have applied for disability benefits but have not been approved, or are an unemployed single individual looking for work who needs temporary help, the Township's General Assistance Program may be for you. If you qualify, we can pay up to \$200 for rent, provide a \$10 food voucher (in addition to food stamps) and a \$57 Kmart voucher for personal needs. **Contact the office during business hours to get more information.**

**VOTER REGISTRATION **

We have several Deputy Registrars who would be happy to register you to vote, update your address, or change your voting status.



SENIOR CARE VOUCHERS \\\

Our Senior Cares food voucher program is still available, BUT based on budget limits, we are at the maximum 30 seniors per month who receive the \$35.00 Save-a-Lot II voucher. If you are 65 or older and earn \$980.83 per month (or \$1,327.50 for a couple) or less, you might qualify.

Call us at 309-788-3417 and an application will be sent to you. Once you have the required paperwork, call for an appointment where we'll review the details and see if you qualify. There are so many people in our Township that qualify for this program that a waiting list is usually necessary as we try to help all those in need.
