November 25th, 2013 - 4:45 p.m.

- A. 2013 Township Levy (Attachment C): Motion to approve the Rock Island Township 2013 Levy with a reduction of \$2,000.00 in the amount of five hundred seventy five thousand dollars (\$575,000.00) made by Trustee Gray. Seconded by Trustee Kirk. Roll Call: Trustee Kerr, Absent; Trustee Gray, Yes; Trustee Thomas, Yes; Trustee Kirk, Yes; Supervisor Carmen, Yes. Motion Passed.
- B. 2013 Holiday Luncheon-Catering Bid: (Attachment D) Supervisor Carmen presented 3 bids to be reviewed by the board. Motion to accept the bid from Montford's at a cost of \$9.90 (includes tip). Seconded by Trustee Gray. Roll Call: Trustee Kerr, Absent; Trustee Gray, Yes; Trustee Thomas, Yes; Trustee Kirk, Yes; Supervisor Carmen, Yes. Motion Passed.

- **D.** Phone/Internet Update: Supervisor Carmen told the board the transfer from AT&T to Mediacom is complete and everything is working. Internet service is much faster than it was. Our cost savings for the year will be about \$3,200.00.
- E. Comments TOI Conference: Board members attending the Conference shared items of interest learned at the Conference. All agreed the seminar was worth attending.

F. Other Activities

- Energy Audit: conducted 11/19 results should be available in the upcoming weeks.
- > Other Building improvements:
 - Supervisor Carmen has talked with representatives from the American Bank and the Blackhawk State Bank to see how much the township might be able to borrow to address our building problems. The amount could be approximately \$200,000.00 at 4% over a 10 year period. More information will be available at the next meeting.
- Website: Augustana Web Guild developed 4 designs for our review. Those board members who reviewed the designs seemed to favor #3 or a combination of elements of the four designs.
- > Health Insurance: Supervisor Carmen and South Rock Island Township met with Lohman Companies to see if we might be able to find our health insurance at a lower cost that would offer comparable coverage.

- G. Sacred Heart Food Pantry/St. Joseph Evening Meal. A total of 2,394 people were provided with food and/or a hot meal from October 21 to November 19th, 2013. Thank you: Sacred Heart Food Pantry and the St. Joseph Evening Meal. Sacred Heart Food Pantry 1211; St. Joseph Evening Meal 1,183.
