#### I. Approval of the Minutes from the July 22nd, 2013 Board Meeting: (Attachment A)

#### **II.** Audit Presentation:

Jim Taylor, Carpentier, Mitchell & Goddard, distributed the 2012-2013 Audit. He reviewed the contents with the Board and explained areas of change from last year. # IV. Review and Approve all claims paid in the Town, General Assistance & Building Funds. June – July 2013: (Attachment B) Motion to approve the claims paid in the Town, General Assistance & Building Funds made by Trustee Kirk. Seconded by Trustee Kerr. Roll Call: Trustee Kerr, Yes; Trustee Gray, Yes; Trustee Thomas, Absent; Trustee Kirk, Yes; Supervisor Carmen, Yes. Motion Passed.

There were no claims in the General Assistance Fund for review.

#### V. Supervisor's Report

A. Request for \$1400.00 from Positive Empowerment Group (PEG): (Attachment C) Rev. Donald Johnson spoke on behalf of the applicant Rev. Dr. Jacqueline Cunningham-Walls, President of PEG. Rev. Johnson explained that PEG had decided to withdraw their membership in the Rock Island Urban Garden Consortium (RIUGC). PEG has 13 gardens located throughout the west side of Rock Island. The RIUGC recently received a grant award from the township of \$2500.00 which they are now asking the town board to award PEG \$1500.00 of that award. PEG requests the board award them a \$2000.00 grant for two sheds and a tiller. Motion by Trustee Kerr to award \$1400.00 to PEG for storage sheds. Trustee Kerr seconded the motion. Roll Call: Trustee Kerr, Yes; Trustee Gray, Yes; Trustee Thomas, Absent; Trustee Kirk, No; Supervisor Carmen, Yes. Motion Passed. Prior to the release of the funding, PEG will provide proof of the not-for-profit status of the institution to which the funding will be paid. A list of the 13 gardens PEG sponsors will also be provided to the town board.

#### B. Bid for Greenbush Garden Pruning/Trimming: (Attachment D)

The board reviewed two bids for Pruning/Trimming Greenbush Garden. 1) Bukowsky in the amount of \$1500.00. 2) Turkle's in the amount of \$750.00. Motion to award the Bid of Turkle's was made by Trustee Gray. Seconded by Trustee Kerr. Roll Call: Trustee Kerr, Yes; Trustee Gray, Yes; Trustee Thomas, Absent; Trustee Kirk, Yes; Supervisor Carmen, Yes. Motion Passed.

#### C. Mission Statement Adoption

Motion made by Trustee Kirk to adopt the Rock Island Township's Mission Statement "To professionally, courteously, equitably and efficiently administer General Assistance, property assessment and other programs and to properly maintain the Township Hall and property for the benefit of Township residents and the building's tenants." Motion to adopt the policy with the following amendments: 1) the board member wishes to join the meeting electronically must provide the means (electronics) to do so. 2) the board member is free to discuss the issues on the Agenda but cannot vote on the issue. 3) per-diem will not be paid to the board member made by Trustee Kerr. Seconded by Trustee Gray. Motion passed.

#### F. Request from Knights of Columbus (KC) for \$200 Donation to Skip-A-Long Day Care(SAL)

Motion made by Trustee Gray to deny the request from the KC and make direct contact with the SAL to determine if they are in need of funding for a specific project or activity. Motion seconded by Trustee Kirk. Roll call: Trustee Kerr, No; Trustee Gray, Yes; Trustee Thomas, Absent; Trustee Kirk, Yes; Supervisor Carmen, Yes. Motion Passed.

#### G. Medical Assistance Catastrophic Insurance (MACI) Coverage.
